SUBJECT : IMPLEMENTATION OF CPRS FOR NON-BROKER ACCOUNT

DATE : 18 August 2022

In line with Customs Memorandum Order No. 34-2019, the Management Information Systems and Technology Group (MISTG) shall be implementing the following enhanced features and functionalities for the Client Profile Registration System (CPRS), effective 22 August 2022.

The following features shall be implemented:

1. Non-brokers may now be registered in the CPRS as declarants. Application for registration of non-brokers as declarants shall be made through the VASPs with the "Client Type" field equal to "Broker", "Nature of Business" field equal to "Declarant", the "PRC ID No." equal to "NONBROKER", and either the Importer TIN or the Exporter TIN of the company that they will be acting for as declarant.
