CUSTOMS MEMORANDUM ORDER
NO. 5392

Subject: Processing of Application for Availment
of GTEB Import Authorization/Import License

In line with the Garments & Textile Export Board Resolution No. 229 S-92 dated April 2, 1992, the function of monitoring the availment of the GTEB Import Authorization and Import License for the raw materials of garments and textile firms shall be performed by the Bureau of Customs effective May 4, 1992.

I. OBJECTIVES:

1. To facilitate the processing and release of shipments of raw materials for garment and textile manufacturers/exporters; and
2. To monitor the availment of the import authorization and import licenses issued by the GTEB.

II. OPERATIONAL PROCEDURES:

1. All importations of raw materials for garments and textile manufacturing of registered/accredited customs bonded warehouses shall be fully covered by an import authorization/import license issued by the GTEB.
2. The Garments and Textile Manufacturing Bonded Warehouse Division (GTMBWD)/FTI Customhouse shall receive a certified copy of the approved Import Authorization/Import License which shall be officially transmitted by the GTEB, as well as the Application for Availment (Annex "A") from the garments and textile bonded warehouse operators.
3. The GTMBWD/FTI Customhouse shall match the Import Authorization/Import License and the Application for Availment, and shall debit or subtract the application for availment from and monitor the utilization of the import authorization/import license.
4. The approved application for availment of the import authority shall be attached to and shall form part of the import entry declaration covering the shipment applied for.

III. EFFECTIVITY:

This Order shall take effect on May 4, 1992.
