SUBJECT : GUIDELINES ON PH-KUWAIT VISA WAIVER AGREEMENT FOR
HOLDERS OF DIPLOMATIC, OFFICIAL AND SPECIAL
PASSPORTS

DATE : 03 July 2018


This refers to all government officials travelling to Kuwait using diplomatic, official and special Philippine passports.

Please be informed that in view of the *PH-Kuwait Visa Waiver Agreement for Holders of Diplomatic, Official and Special Passports*, government officials travelling to Kuwait should coordinate their proposed visit through the Department of Foreign Affairs and submit the following requirements to such Department at least five (5) working days prior to the proposed visit to Kuwait:

1. Complete name of the visiting official;
2. Passport number;
3. Purpose of the visit; and
4. Flight details (including the flight numbers and the dates of arrival in and departure from Kuwait).
