CUSTOMS MEMORANDUM CIRCULAR NO. 21-2020

SUBJECT: National Tobacco Administration (NTA) – Issuance of Memorandum Circulars for the Exemption from Filing of Commodity Clearance for Exportation, Importation, and Transshipment of Tobacco Products for Personal Consumption and Tobacco-Free Products

Attached is the letter dated 26 November 2019 from Mr. Robert L. Seares, M.D., Administrator and Vice- Chairman, NTA Governing Board informing this Bureau on the two (2) recently issued Memorandum Circulars in connection with the exemption from the filing of commodity clearance for exportation, importation, and transshipment of tobacco products for personal consumption and tobacco-free products.

The issued Memorandum Circulars are the following:

a. Memorandum Circular No. 003, Series of 2019 that took effect on 01 September 2019. The said MC is for the exemption in the filing of commodity clearance for exportation, importation, and transshipment of certain maximum volume of tobacco products; e-cigarettes, e-juice for personal consumption as follows:

1. Cigarettes	-	Not exceeding five (5) reams (50 packs),
		per passenger/consignee
2. Cigars	-	Not exceeding twenty (20) sticks, per
		passenger/ consignee
3. Snus	_	Not exceeding ten (10) tins or maximum of
		two hundred (200) pieces per
		passenger/consignee
4. E-Cigarettes	-	Not exceeding two (2) sets of Atomizer
		device, per passenger/consignee
5. E-juices	-	Not exceeding 200 mL, per
		passenger/consignee
6. Parts/ Accessories of	-	Not exceeding 100 grams, per
Atomizer Devices		passenger/consignee



- b. Memorandum Circular No. 004, Series of 2019 that took effect on 25 September 2019. MC No. 004 is the exemption of filing of commodity clearance for exportation, importation and transshipment of tobacco free products whether for personal consumption or for sale/distribution as follows:
 - i. Snus;
 - ii. E- Liquid;
 - iii. Pod; and
 - iv. Other similar tobacco- free products.

For your information, guidance and appropriate action.

Please be informed that the National Tobacco Administration (NTA) has recently issued two (2) Memorandum Circulars in connection with the exemption from the filing of commodity clearance for exportation/importation/trans-shipment of tobacco products for personal consumption and tobacco-free products, to wit:

a. Memorandum Circular No. 003, Series of 2019 (took effect on 01 September 2019) Exemption the filing of commodity clearance exportation/importation/transshipment of certain maximum volume of tobacco products/e-cigarette/e-juice for personal consumption as follows:

WHEREAS, pursuant to its regulatory powers vested under Executive Order No. 245, the National Tobacco Administration (NTA), has issued the Rules and Regulations Governing Exportation/Importation/Transshipment of Tobacco Leaf/Tobacco Product/Other Tobacco Related Materials and Spare parts, as amended:

WHEREAS, pursuant to the aforesaid Rules and Regulations, as amended, all Exporters/Importers/Transshippers are required to secure from the NTA the Export/Import/Transshipment Commodity Clearances (ECC/ICC/TCC) for all their shipments of tobacco leaf, tobacco products and other tobacco related materials, ingredients and spare parts, including e-cigarettes and e-juices:

WHEREAS, there are exportation/importation/transshipment of tobacco commodities, other tobacco related materials, ingredients and spare parts, e-cigarettes and e-juices of minimal volume, for personal consumption;

NOW THEREFORE, for and in consideration of the foregoing premises, the following Memorandum Circular is hereby adopted, to wit:

Section 1. Tobacco commodities, other tobacco related materials, ingredients and spare parts, e-cigarettes and e-juices are exempted from the filing of commodity clearance for the following volume or net weight, for personal consumption, to wit:

> Cigarettes not exceeding 5 reams (50 packs), per

Passenger/consignee

Cigars not exceeding 20 sticks, per

passenger/consignee

Snus not exceeding 10 tins or maximum of

200 pcs, per passenger/consignee

E-Cigarettes not exceeding 2 sets of Atomizer device,

per passenger/consignee

e. E-juices not exceeding 200 ml, per passenger/

consignee

Parts/Accessories of Atomizer Devices

not exceeding 100 grams, per

Passenger/consignee

Provided, that the subject tobacco commodities/related materials is a commodified materials is a commodities of the commodities passenger's hand-carried or check-in baggage or sent via parcels/courrier CERTIFIED TRUE COPY

Section 2. In excess of the above quantities, the concerned exporter/importer/transshipper shall be required to secure the necessary ECC/ICC/TCC from the NTA.

Section 3. This Memorandum Circular shall take effect on 01 September 2019. The foregoing shall be published in a newspaper of general circulation and shall be filed with the Office of the National Administrative Registrar (ONAR), U.P. Law Center.

WHEREAS, pursuant to its regulatory powers vested under Executive Order No. 245, the National Tobacco Administration (NTA), has issued the Rules and Regulations Governing Exportation/Importation/Transshipment of Tobacco Leaf/Tobacco Product/Other Tobacco Related Materials and Spare parts, as amended;

WHEREAS, pursuant to the aforesaid Rules and Regulations, as amended, all Exporters/Importers/Transshippers are required to secure from the NTA the Export/Import/Transshipment Commodity Clearances (ECC/ICC/TCC) for all their shipments of tobacco products;

WHEREAS, there are exportation/importation/transshipment of tobacco-free commodities for personal consumption or sale/distribution which is beyond the regulatory authority of the NTA;

NOW THEREFORE, for and in consideration of the foregoing premises, the following Memorandum Circular is hereby adopted, to wit:

Section 1. Tobacco-free commodities are hereby exempted from the application of NTA commodity clearance, whether for export/import/transshipment.

Section 2. The following are examples of Tobacco-free products, to wit:
