The countries affected by African wine Fever (ASF) now includes **Laos**. Copy of Department of Agriculture Memorandum Order on the matter is hereto attached for reference.

All District Collectors, Sub-port Collectors and all others concerned are directed to coordinate with DA-BAI personnel in all international air and sea ports for the conduct of rigid inspection of incoming shipments, including checked-in and hand-carried luggage of all incoming passengers from ASF affected countries, and confiscate and destroy all pork and pork-related products coming from the said countries within 24 hours from interception.

TEMPORARY BAN ON THE IMPORTATION OF DOMESTIC AND WILD PIGS AND THEIR PRODUCTS AND BY-PRODUCTS INCLUDING PORK MEAT, PIG SKIN AND SEMEN ORIGINATING FROM Luos

WHEREAS, Section 9 and 7 (2) and (4) of Executive Order No. 292 provides the authority and responsibility for the exercise of the mandate of the Department and for the discharge of its powers and functions shall be vested in the Secretary who shall have supervision and control of the Department, to establish the policies and shaddard, for the operation of the Department pursuant to the approved programs of government and promulgate administrative issuances necessary for the efficient administration of the offices under the Secretary and the proper execution of the laws relative thereto;

WHEREAS, Section, 1770 of Act No. 2711 (Revised Administrative Code of 1917) which was adopted by me spormion together with Sections 1761-1769, in Section 5 of Act 3639 (Charter of BAI) empowers the Department Head to usue a general order preventing the entry of animals, animal effects, parts or products trom any country with dangerous communicable animal disease;

WHEREAS, based on the official report submitted by Dr. Somphanh Champhengxay, Director General, Department of Licework and Fisheries, Ministry of Agriculture and Forestry, Vientiane, Laos to the World Organisation for Animal Featth (OIE), that there were outbreaks of African Swine Fever (ASF) in Toumlan, ton availe those affecting backward swine as confirmed by the National Animal Health Laboratory (NAHL)

WHEREAS, there is a need to prevent the entry of ASF virus to protect the health of the local swine population:

NOW, THEREFORE, I, EMMANUEL F. PIÑOL, Secretary, Department of Agriculture, by the powers vested in me in Law, do hereby institute the following emergency measures for the importation of domestic and wild

- Banning the requestation or domestic and wild pigs and their products, including pork meat and
- Immediate suspension of the processing, evaluation of the application and issuance of Sanitary and Phytosanitary (Six) import clearance to the above-stated commodities; Moppinge and confiscation of all shipments of the above stated commodities into the country by all
