THIS AGREEMENT made and entered into this 15<sup>th</sup> day of March, 2013 by and between **BUREAU OF CUSTOMS**, herein represented by *Rozzano Rufino B. Biazon*, Commissioner (hereinafter called "Entity") and **LOTRIM Construction, Inc.** herein represented by *Engr. Odilon Marlon L. Gaviola*, General Manager with address at #31 Quimpo Boulevard, Matina, Brgy. Bucana, Davao City (hereinafter called "Contractor"):

WHEREAS, the Entity is desirous that the Contractor executes the **Re-bidding of the Expansion of Administration Building at the Port of Davao** (hereinafter called "the Works") and the Entity has accepted the Bid for **Seventeen Million Two Hundred Three Thousand Two hundred Three pesos and 18/100 (Php 17,203,203.18)** only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.




