Subject : Intellectual Property Recordation of
STIHL Trademark

[Registered for a term of Ten (10) years]
Goods : (Class 07) Power saws, parts thereof, spare parts
and accessories, namely: saw chains, guide rails,
sprockets, clutches, carburetors, oil pumps; power-
driven; power-driven free cutters, power driven,
power-driven sprayers for agricultural and forestry
purposes, power-driven earth augers, power-driven
sharpeners for saw chains; forestry machines and
power-driven forestry equipment, wood-harvesting
machines; power-operated, portable blowers, with
controlled air flow for the removal of movable solid
and liquid media as well as for the drying of damp
surfaces.
- 08 Hand-operated parting off grinders; hand
operated hedge clippers; hand-operated
sharpeners for saw chains.

Having complied with the requirements of CAO-9-2008, the above-mentioned trademark has been recorded in the IPR (Intellectual Property Rights) Registry, Bureau of Customs, thus shall be accorded the rights and benefits emanating from such registration as therein provided.

The recordation of said trademark shall be valid for two (2) years from signing hereof, and renewable every two years thereafter.
