



1. This memorandum supersedes the memorandum of 27 March 2014 on the same topic.
2. You are hereby directed to refer to the Imports & Assessment Service (IAS) all entries of shipments containing IRON AND STEEL covered by the following AHTN headings, **prior to their release**: Please note that the values below have changed for all the AHTN headings except for 7216.
  - a. AHTN 7207, with Customs value of USD 0.48 ~~0.55~~ per kg, or less
  - b. AHTN 7208, with Customs value of USD 0.55 ~~0.59~~ per kg, or less
  - c. AHTN 7209, with Customs value of USD 0.62 ~~0.71~~ per kg, or less
  - d. AHTN 7210:
    - i. For 7210 49, with Customs value of USD 0.72 per kg, or less
    - ii. All others under 7210, with Customs value of USD 0.80 ~~0.82~~ per kg, or less
  - e. AHTN 7216, with Customs value of USD 0.71 per kg, or less
  - f. AHTN 7225, with Customs value of USD 0.55 ~~0.57~~ per kg, or less
  - g. AHTN 7227, with Customs value of USD 0.50 ~~0.57~~ per kg, or less
3. Shipments which were not released because of the memo of 27 March 2014 which are:
  - a. not subject to alert orders, and
  - b. which have values above the new values shown in section #2 above may now be released without prior clearance from IAS, subject to compliance with all other laws and regulations.

4. **No release of shipments of products under these tariff headings, with values at or lower than those shown above, should be made without prior clearance from IAS.**
5. The Imports & Assessment Service (IAS) will provide value recommendations to the Formal Entry Division (FED) or equivalent units.
6. Proofs of Payment submitted shall be subjected to post-entry audit and verification with our commercial trade attaché in the country of origin.
7. For strict and immediate compliance.
