SUBJECT: Lost Original and Triplicate Copies of IED No. 26618837 issued to CJ Toyota Tsusho Philippines, Inc.


The original and triplicate copies of Import Entry Declaration No. 26618837 dated 25 January 2010 with bank machine validated payment in the amount of PHP7,248,938.00 reflected on its face, issued to CJ TOYOTA TSUSHO PHILIPPINES, INC. was reported lost. To that effect, an Affidavit of Loss was executed by Mr. Alex L. Senajon, Finance Manager of the said company.

In order to ensure that unauthorized usage thereof is avoided, it is incumbent upon the Chief, Collection Divisions/Units to keep a permanent record of all lost documents as reference if secondary evidence is availed on in lieu of the lost original document. Further, the offices concerned shall ensure that the amount collected had been remitted to the Bureau of Treasury and that said copy of IED if recovered, will not be used or utilized as they are deemed cancelled.
