## KNOW ALL MEN BY THESE PRESENTS:

The **BUREAU OF CUSTOMS**, a national agency of the Philippine Government under the Department of Finance, constituted and established under the laws of the Republic of the Philippines with principal office address at Office of the Commissioner Building, Gate 3, South Harbor, Port Area, Manila City, represented herein by its Commissioner, **BIENVENIDO** Y. RUBIO herein referred to as "**Procuring Entity**";

The **CASEDIST INCORPORATED** with principal office address at 3755 SBB Bldg., Sun Valley Drive, Sun Valley Parañaque City represented herein by its Vice-President, **GLENN MAGSINO** hereinafter referred to as **"Service Provider"**.

WHEREAS, the Procuring Entity conducted a public bidding for the project "SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF CT BAGGAGE SCANNER AND BODY SCANNER FOR THE BUREAU OF CUSTOMS" in the amount of FIVE HUNDRED NINETY-SEVEN MILLION NINE HUNDRED FIFTY-SEVEN THOUSAND FIVE HUNDRED SIXTY-SEVEN PESOS (PhP597,957,567.00) and was determined to be the Single Calculated Responsive Bid.

  - Annex A. The Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - Annex B. Schedule of Requirements;
  - Annex C. Technical Specifications;
  - Annex D. General Conditions of Contract;
    Annex E. Special Conditions of Contract;
  - Annex E. Special Conditions of Contract; Annex F. Notice of Award; and
  - Annex G. Performance Security.
- The Service Provider hereby covenants with the Procuring Entity to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
- 4. The Procuring Entity hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
