CONTRACT FOR THE MAINTENANCE, MANAGED TECHNICAL SUPPORT, AND SOFTWARE AND HARDWARE UPGRADE OF THE CORE RELATIONAL DATABASE MANAGEMENT SYSTEM COMPONENTS OF THE BUREAU OF CUSTOMS

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT**, made and entered into this DEC 27 day 2023, 2023, by and between:

The **BUREAU OF CUSTOMS**, a national agency of the Philippine Government under the Department of Finance, constituted and established under the laws of the Republic of the Philippines with principal office address at Office of the Commissioner Building, Gate 3, South Harbor, Port Area, Manila City, represented herein by its Commissioner, **BIENVENIDO Y. RUBIO** herein referred to as "**Procuring Entity**";

-and-

The **RADENTA TECHNOLOGIES INC.** with principal office address at Unit 2BC, CBC Corporate Center, 724 Shaw Blvd. Wack Wack, Mandaluyong City represented herein by its Business Development Manager & Authorized Representative, **MA. NATHALIE ROSE C. REGALA** hereinafter referred to as "**Service Provider**".

WHEREAS, the Procuring Entity conducted a public bidding for the project "**MAINTENANCE, MANAGED TECHNICAL SUPPORT, AND SOFTWARE AND HARDWARE UPGRADE OF THE CORE RELATIONAL DATABASE MANAGEMENT SYSTEM COMPONENTS OF THE BUREAU OF CUSTOMS**" in the amount of **EIGHTY EIGHT MILLION EIGHT HUNDRED THOUSAND PESOS (PhP88,800,000.00)** and was determined to be the Single Calculated Responsive Bid.

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties hereby mutually stipulate and agree as follows:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract (Annex D and E).
2. The following documents shall form, be read, and construed as part of this Contract:
 - Annex A. The Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - Annex B. Schedule of Requirements;
 - Annex C. Technical Specifications;
 - Annex D. General Conditions of Contract;
 - Annex E. Special Conditions of Contract;
 - Annex F. Notice of Award; and
 - Annex G. Performance Security.
3. The Service Provider hereby covenants with the Procuring Entity to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the Contract Price

or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
