The BUREAU OF CUSTOMS, a national agency of the Philippine Government under the Department of Finance, constituted and established under the laws of the Republic of the Philippines with principal office address at Office of the Commissioner Building, Gate 3, South Harbor, Port Area, Manila City, represented herein by its Commissioner, BIENVENIDO Y. RUBIO herein referred to as "Procuring Entity";

-and-

The ALERT GENERAL SERVICES CORPORATION the Philippines, with principal office address at Unit 403 Jafer Place Building, Eisenhower Street Greenhills, San Juan City, represented herein by its Business Development Officer, JAMIE M. DIMAANO hereinafter referred to as "Service Provider".

#### WITNESSETH:

WHEREAS, the Procuring Entity conducted a public bidding for the project "PROCUREMENT OF JANITORIAL SERVICES" in the amount of TWENTY MILLION NINE HUNDRED NINETY-SIX THOUSAND THREE HUNDRED FIFTEEN PESOS AND SIXTY-FOUR CENTAVOS (PhP20,996,315.64) for the period of July 2023 to December 2023, and was determined to be the Single Calculated Responsive Bid;

The Procuring Entity hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
