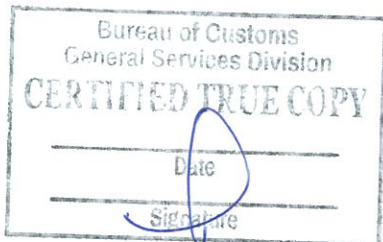

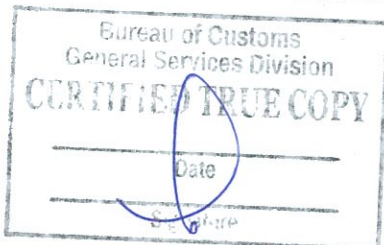

This **CONTRACT**, made and entered into this NOV 30 2023 day of _____, 2023, by and between:

The **BUREAU OF CUSTOMS**, a national agency of the Philippine Government under the Department of Finance, constituted and established under the laws of the Republic of the Philippines with principal office address at Office of the Commissioner Building, Gate 3, South Harbor, Port Area, Manila City, represented herein by its Commissioner, **BIENVENIDO Y. RUBIO** herein referred to as "**Procuring Entity**";

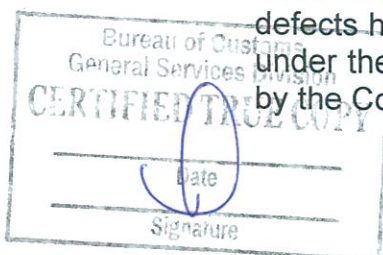

The **IONE RESOURCES INC.** with principal office address at 1006 The Centerpoint Condominium Julia Vargas Ave., Cor. Garnet Rd., Ortigas Center, Pasig City represented herein by its Sales Executive, **ANALYN G. ANTONIO** hereinafter referred to as "**Service Provider**".

WHEREAS, the Procuring Entity conducted a public bidding for the project "**SUPPLY AND DELIVERY OF ADDITIONAL LOW ORBIT SATELLITE LINKS FOR THE BUREAU OF CUSTOMS**" in the amount of **SEVENTY NINE MILLION NINE HUNDRED NINETY-FOUR THOUSAND NINE HUNDRED NINETY-NINE PESOS AND SIXTY CENTAVOS (PHP79,994,999.60)** and was determined to be the Single Calculated Responsive Bid.

2. The following documents shall form, be read, and construed as part of this Contract:
 - Annex A. The Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - Annex B. Schedule of Requirements;
 - Annex C. Technical Specifications;
 - Annex D. General Conditions of Contract;
 - Annex E. Special Conditions of Contract;
 - Annex F. Notice of Award; and
 - Annex G. Performance Security.
3. The Service Provider hereby covenants with the Procuring Entity to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
