Please take note of the following letters in connection with the implementation of Republic Act 8178 insofar as the collection of “In Quota” MAV mechanism from the Special Account in the General Fund (Agricultural Competitiveness Enhancement Fund) shall be derived:

Henceforth, to enable the Department of Agriculture to collect the funds from the Department of Budget & Management, all revenue collections arising from In-Quota MAV retroactive to January 1, 1998, shall be consolidated and reported to the Bureau of Treasury every end of the month by the Director, Import and Assessment Service as computed at the Formal Entry Divisions/Units and remitted to the Treasury by the Chiefs, Collection Divisions/Units of the Ports of Entry.

This order shall be made effective immediately.

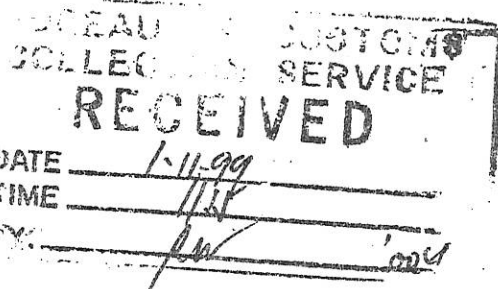
