REQUEST OF CONGRESSMAN HERMINIO G. TEVES FOR DATA IN AID OF LEGISLA-TION

Attached herewith, for your information and reference, are copies of the two (2) letters, dated August 26 and November 14, 1998 from Congressman Herminio G. Teves subject of the within copy of the Ist indorsement dated December 14, 1998 from the Deputy Commissioner, Internal Administration Group, this Bureau.

Considering that the requested data are contained in the import entries actually filed in your ports for the release of importations enjoying tax and duty exemption privileges, you are hereby directed to submit the following data:

- 1. List of tax exemptions given for the last five years.
- Total amount of tax exemptions also for the last five
- years. Amount of VAT collected by your ports in the last five years or from the years 1993 to 1997

to the Statistical Analysis Division, Revenue Service, this agency.

The required report should be submitted within one (1) month from the effectivity of this Order to the said Division which in turn shall transmit a consolidated data to the aforesaid Congressman within one (1) month immediately following the first month from the effectivity of the Order.

For purposes of statistical record, all collectors of customs whose ports where no such importations were made in the said years from which the requested data are obtainable, shall notify the Division on the matter.

This Order shall take effect immediately.

All concerned shall be guided accordingly.


