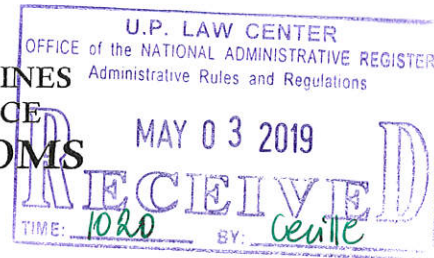

CUSTOMS MEMORANDUM ORDER

NO. 10-2019

**Subject: Revoking Customs Memorandum Order No. 44-2009
(CPRS Registration of Once-A-Year Importer
[Previously First and Last Importation Scheme])**

WHEREAS, CMO No. 11-2014, as supplemented by CMO No. 5-2018, embodies the Revised Guidelines for Registration of Importers and Customs Brokers with the Bureau of Customs (BOC).

WHEREAS, CMO No. 23-2018 directs the Account Management Office (AMO) to submit for approval of the Office of the Commissioner all applications for renewal, re-application, reinstatement, suspension (*with lifting of suspension*), revocation or cancellation.

WHEREAS, CMO No. 44-2009, provides for the CPRS Registration of Once-A-Year Importer (Previously First and Last Importation Scheme) which may be an individual, company, corporation or partnership with a single shipment covered by one Bill of Lading and One Import Entry Declaration.

WHEREAS, the Once-A-Year Importer Application of an Importer is filed and evaluated by the CISS (Officer-In-Charge) in every Port/District and recommended for approval by the District Collector of the port.

WHEREAS, the CPRS registration of the Once-A-Year Importer is limited to one importation within one year (365 days) from the approval of the Office of the Commissioner.

WHEREAS, there is a need to centralize the accreditation of all importers under AMO for the uniformity of requirements and better/close monitoring and coordination.

NOW THEREFORE, premises considered, CMO No. 44-2009 dated 2 October 2009, is hereby **REVOKED**. All importers including Once-A-Year Importers shall apply for accreditation directly with AMO, strictly complying with the existing CMOs and other rules and regulations on accreditation, and the following guidelines:

1. The AMO shall set the accreditation procedure, the amount of fees payable, and the documentary requirements for individual, company, corporation, partnership or cooperative. Duly Registered/Accredited Once-A-Year Importers are given the option to use their existing registration/accreditation until expiration or apply for accreditation as a regular importer with AMO under existing CMOs.
2. The AMO shall create and maintain a Compliance Monitoring Database of the accredited individual, company, corporation, partnership or cooperative and their shipments.
3. All shipments must contain the description of the goods and shall be subjected to 100% physical examination.
4. For effective monitoring, the AMO is required to submit a monthly report to the Office of the Commissioner relative to the operations of the accredited importers covered by this Order.

The provisions of existing CMOs and rules and regulations inconsistent herewith are hereby revoked or modified/amended accordingly.
