AUTHORIZATION OF THE ASSISTANT SECRETARY FOR PROCUREMENT AND PROJECT IMPLEMENTATION TO ISSUE A SPECIAL POWER OF ATTORNEY IN FAVOR OF SUMITOMO CORPORATION FOR PURPOSES OF IMPORTATION OF THE SPARE PARTS NECESSARY FOR THE METRO RAIL TRANSIT LINE 3 (MRT-3) REHABILITATION PROJECT PER DOTR SPECIAL ORDER NO. 2019-217.

Section 2.5 of the subject RMA gives Sumitomo the discretion to order, store, maintain, and generally expedite the delivery of all spare parts necessary for the efficient and effective rehabilitation and maintenance of the MRT-3.

Consistent with the objectives of the RMA, and in accordance with Department Order No. 2019-005,1 the Assistant Secretary for Procurement and Project Implementation, GIOVANNI Z. LOPEZ, is hereby given the power to issue a Special Power of Attorney and to act as Principal therein, for purposes of authorizing Sumitomo and/or its duly authorized representative/s to (1) sign the custom clearance; and (2) request for the lifting of abandonment, if necessary, during the importation of all spare parts related to the MRT-3 Rehabilitation Project, on behalf of this Department.

All previous orders, circulars, and memoranda inconsistent herewith shall be deemed revoked, superseded, or amended accordingly.

This Order shall take effect immediately.
