CUSTOMS MEMORANDUM ORDER
NO. 17-2014

SUBJECT: Additional Exemption from the Imposition of Provisional Anti-Dumping Duty on Wheat Flour Imports from Turkey as provided under CMO No.12 - 2014

Pursuant to the Department of Agriculture Addendum to the Addendum to the Department Order entitled "In the Matter of the Preliminary Determination of the Anti-Dumping Investigation Relating to Wheat Flour Importers from Turkey (AHTN Code 1101.00.10) (Anti-Dumping Measure [ADM] Case No. 01-2013)" which was issued on May 7, 2014, the following exporters shall be exempted from the imposition of the residual duty or "all other rate" of 39.26% for all types of wheat flour from Turkey:

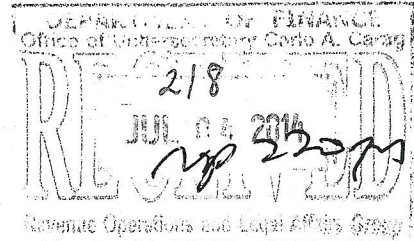
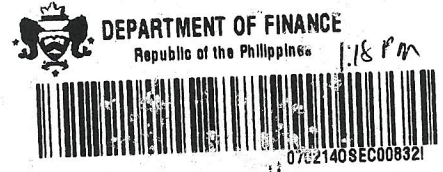

Dear Secretary Purisima:

This is in reference to our letter dated 02 May 2014 regarding the request for the imposition of a provisional anti-dumping duty, in the form of cash bond, on imported wheat flour from Turkey.

The Department of Agriculture published a second addendum last 13 May 2014 in Philippine Daily Inquirer and 15 May 2014 in Philippine Star which indicated the exporters that shall be exempted from the imposition of the residual duty or "all others rate" of 39.26% for all types of wheat flour originating from Turkey under AHTN Code 1101.00.10 defined in Section 18 paragraph (e) of the IRR of RA 8752. These exporters, per preliminary investigation, were found not dumping wheat flour to the Philippines and therefore, should not be imposed the provisional anti-dumping duty on the type of wheat flour they export to the Philippines. These exporters are the following:

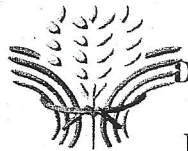



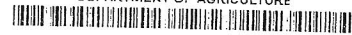
