#### **DESCRIPTION OF GOOD**

#### "JIF® CREAMY PEANUT BUTTER"

Based on the product information, product label, ingredients declaration, production process, photograph of the product, and sample submitted, subject article is a thick, light-brown peanut butter spread. It is composed of peanuts, sugar, molasses, fully hydrogenated rapeseed and soybean oil, and salt, among others. It is produced by roasting groundnut kernels, followed by grinding, and then mixing with the other ingredients. Subject article is packed in 16-oz and 12-oz polyethylene terephthalate (PET) jars.



#### **REASONS FOR CLASSIFICATION**

Heading 20.08 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers fruit, nuts and other edible parts of plants, otherwise prepared or preserved, whether or not containing added sugar or other sweetening matter or spirit, not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers fruit, nuts and other edible parts of plants, whether whole, in pieces or crushed, including mixtures thereof, prepared or preserved otherwise than by any of the processes specified in other Chapters or in the preceding headings of this Chapter. It includes, inter alia, "peanut butter", consisting of a paste made by grinding roasted ground-nuts, whether or not containing added salt or oil.

In view thereof, subject article is classified under AHTN 2022 subheading 2008.11.20, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



# **DESCRIPTION OF GOOD**

# "MOTHERLOVE® POSTPARTUM SITZ BATH SPRAY"

Based on the cosmetic product safety statement, product formula specifications, exposure and margin of safety, photograph of the product, and sample submitted, subject article is a perineal spray in the form of a pale-yellow, water-like, clear liquid with an alcohol, lavender, and mild bitter herbs odour. It consists of distilled water; alcohol; extracts of Hamamelis virginiana (witch hazel) leaf, Achillea millefolium (yarrow) leaf and flower, and Arctostaphylos uva-ursi (uva ursi) leaf; and Lavandula angustifolia (Lavender) flower oil. Packed in a 2-oz (59 mL) glass spray-bottle in a carton box, subject article is sprayed onto sore perineal muscles to ease discomfort after childbirth.



#### **REASONS FOR CLASSIFICATION**

Note 2 to Section VI of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 states that subject to Note 1 above, goods classifiable in heading 30.04, 30.05, 30.06, 32.12, 33.03, 33.04, 33.05, 33.06, 33.07, 35.06, 37.07 or 38.08 by reason of being put up in measured doses or for retail sale are to be classified in those headings and in no other heading of the Nomenclature.

Heading 30.04 of the AHTN 2022 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that even if no indications are given, unmixed products are to be regarded as being put up for retail sale for therapeutic or prophylactic use if they are put up in a form clearly specialised for such use.

In view thereof, subject article is classified under AHTN 2022 subheading 3004.90.59, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

# "UC-II® POWDERED UNDENATURED TYPE II COLLAGEN"

Based on the product composition, certificate of analysis, manufacturing process flowchart, product literature, packaging information, and product label submitted, subject article is a white or cream-coloured powder composed of chicken sternum cartilage and potassium chloride (stabilizer). It is produced by washing the harvested chicken sternum cartilage with chlorine-based sanitizer, followed by freezing, grinding, mixing with potassium chloride, and air drying. Packed in a 1-kg, 5-kg or 15-kg polyethylene bag inside a plastic pail, subject article contains undenatured (native) Type II collagen for use in the manufacture of dietary supplements and functional food and beverages.

#### 5 REASONS FOR CLASSIFICATION

Heading 04.10 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers insects and other edible products of animal origin, not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers insects (as defined in Note 6 to this Chapter) and other products of animal origin suitable for human consumption, not specified or included elsewhere in the Nomenclature.

In view thereof, subject article is classified under AHTN 2022 subheading 0410.90.90, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

#### "INTAKE HEAD"

Based on the brochure, technical drawings, material test report, and other technical information submitted, subject article is a seawater intake head made of steel conforming to Japanese Industrial Standards (JIS) GS101 SS400. It has a chlorine diffuser, sacrificial aluminium alloy anodes, and epoxy resin finish. To be imported as a replacement part/component of a power plant's cooling water piping system, subject article has the following specifications:

Inlet size (Ø x H) (mm)	10,000 x 2,600	
Shaft size (Ø x H) (mm)	5,200 x 6,200

#### **REASONS FOR CLASSIFICATION**

Heading 73.07 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers tube or pipe fittings (for example, couplings, elbows, sleeves), of iron or steel. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers fittings of iron or steel, mainly used for connecting the bores of two tubes together, or for connecting a tube to some other apparatus, or for closing the tube aperture. This heading therefore includes flat flanges and flanges with forged collars, elbows and bends and return bends, reducers, tees, crosses, caps and plugs, lap joint stub-ends, fittings for tubular railings and structural elements, off sets, multi-branch pieces, couplings or sleeves, clean out traps, nipples, unions, clamps and collars.

In view thereof, subject articles are classified under AHTN 2022 subheading 7307.99.90, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".
