SUBJECT: FURTHER AMENDING CMO NO. 45-90
ON OVERTIME SERVICES

1. No. 1 of the first paragraph of CMO No. 45-90 is hereby amended to include: "shipments of raw materials and supplies imported and/or consigned to duly accredited members of the semi-conductor industry association."

Their import/export entry papers may be processed and the shipments if in order, released after office hours; during Saturdays, Sundays and official holidays.

2. Attached is a list of accredited members of the SEMI-CONDUCTOR ELECTRONICS INDUSTRY FOUNDATION INC. (SEIFI), Annex "A" for purposes of determining accredited members of the Foundation.

3. The expenses that may be incurred by the rendition of overtime including the rates thereof, shall be borne by the importer requesting for overtime shall be governed by CAO No. 1-85 implementing Section 3506 of the Code.

4. All other provisions of CMO No. 45-90 shall remain in force and effect.

This Order shall take effect immediately.
