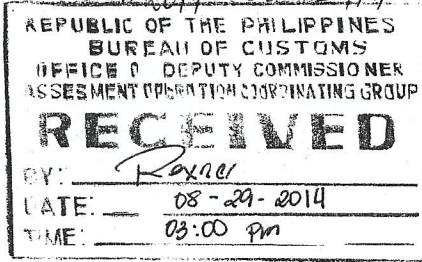

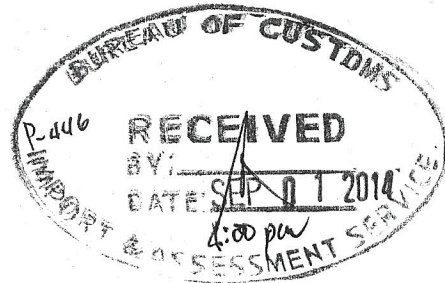
This refers to your letter, requesting for the cancellation of your BOI registration as New Producer of Steel Drums.
