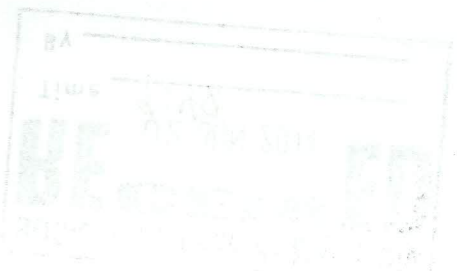


This refers to your letter, requesting for the cancellation of your BOI registration and waiver of the penalty for late submission of reports.
