

2. **Pre-Bid conference.** The Pre-Bid Conference shall be held at 10:00 AM of **March 13, 2019** at the Bureau of Customs-Port of Surigao, 2/F Conchita Building, Borromeo Street, Surigao City. It shall be open to prospective bidders.
3. **Complete Set of Bidding Documents.** A complete set of bidding documents for a non-refundable fee of **One Thousand Pesos (P1,000.00)** can be obtained from the Port of Surigao, Surigao City, the Sub-Port of Bislig, Mangagoy, Bislig City, and the Sub-Port of Nasipit, Butuan City.
4. **Submission of Sealed Bids and Bid Bonds.** The sealed bids shall be received by the Secretariat of the Disposal Committee at or before 1:00 o'clock in the afternoon of **March 14, 2019** at the address given in paragraph 2 hereof. No bid submitted thereafter shall be entertained.

A bid bond in cash for a given lot in the amount shown in the table in paragraph one hereof must be submitted together with the bid in a sealed envelope. Unsealed bid envelope or bids below the floor price or without or below the prescribed amount of bid bond shall be rejected at the opening of the bids.

5. **Bid Opening.** The opening of the bids shall be at 2:00 o'clock in the afternoon of **March 14, 2019** in the District Collector's Office at the address given in paragraph 2 hereof.
6. **Option to Reject or Accept Bids.** The Bureau of Customs-Port of Surigao reserves the right to accept or reject any or all bids, waives any defect therein and accepts the offer found most advantageous to the Agency.
7. **Ocular Inspection.** Ocular inspection of the materials is scheduled on **March 8, 2019** at 3 PM. Thereafter, other schedule of ocular inspection may be arranged upon request.
