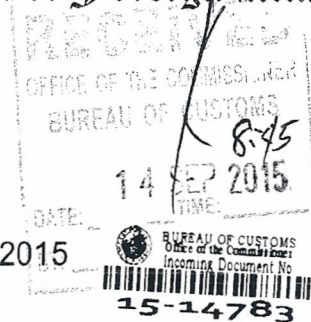

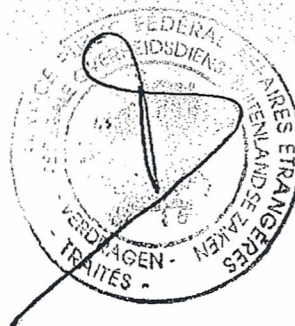

Acceptance by the Republic of Colombia.

On the 25th day of June 2015, the act of acceptance of the Republic of Colombia to the above-mentioned international Act, of which the Belgian Government is the depositary, has been deposited with the Federal Public Service Foreign Affairs, Foreign Trade and Development Cooperation of Belgium.

In accordance with Article XX paragraph c of the Convention, the above-mentioned Amendment shall come into force three months after receipt by the Federal Public Service Foreign Affairs of Belgium of the notice of acceptance by all the Contracting Parties.

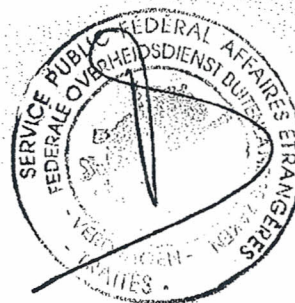
