RE : RA 10863 COMPLIANCE READINESS PROCESS RE-ENGINEERING PROGRAM

Pursuant to Section 109 of RA 10863, the Bureau of Customs is now required by law to transform its operations into a modernized, technology and software-enabled *paperless* environment. As a matter of fact, every title and chapter that constitutes RA 10863, will implicitly require technology and software enablement of all procedure-level tasks of the Bureau.

It is therefore incumbent upon the Management Information Systems Technology Group to take the leadership in the re-engineering of processes and procedures at the earliest possible stages of the our transition processes parallel to the development of the requisite Implementing Rules and Regulations of RA 10863.

The RA10863 COMPLIANCE READINESS PROCESS RE-ENGINEERING PROGRAM will consist of a series of planned workshops, training sessions, systems architecture and detailed design activities involving all units engaged in the regulatory value chain activities of the Bureau of Customs.

The output of the RA10863 COMPLIANCE READINESS PROCESS RE-ENGINEERING PROGRAM will serve as the basis of the enterprise architecture and the definition of explicit business rules that will drive the systemic design and application behavior of the *processing and regulatory system* of the Bureau of Customs to replace the legacy and outdated E2M system in its entirety.


