With reference to the memorandum of Executive Secretary Salvador Medialdea dated 27 April 2017, all concerned are hereby directed to submit their accomplishment reports to include the entire month of April 2017 for the President's Report.

Moreover, as per memorandum of Cabinet Secretary Leoncio Evasco, Jr. dated 23 February 2017, the inputs shall be continually updated every month-end until 30 June 2017.

Attached is the memorandum of the undersigned dated 27 March 2017 for easier reference and updating of BOC inputs. Accomplishments other than what is indicated thereat which addresses anti-corruption and streamlining government services should be included.

The Presidential Management Staff strictly requires that data and figures indicated in the reports bear comparison against the actual accomplishment of the same period of the immediately preceding year (e.g. actual accomplishments in 2015 vs actual accomplishments for the period July 2016 to June 2017).

Updated reports as of April must be sent to the Office of the Commissioner, copy furnish the Public Information and Assistance Division, or email to faeldonn@customs.gov.ph, cc: piad@customs.gov.ph on or before 11 May 2017.

Updated inputs for the months of May and June must be submitted on June 02 and July 03, 2017 respectively.

SUBJECT : BOC INPUT TO THE PRESIDENT'S SONA

DATE : 27 March 2017

Relative to the recently held SONA workshop in Malacanang, topics were identified as agency inputs essential in the upcoming Presidents' Report to the People (July 2016-July 2017) anchored on the theme, "Comfortable Life for All Filipinos."

It was identified that the implementation of duty-free privileges as provided in CAO 2-2017 (De Minimis Importation) and CAO 5-2016 (Consolidated Shipment of Duty and Tax-Free Balikbayan Boxes) will highlight our report, and classified under Enhanced Delivery of Public Service. Also included are the bureau's streamlining, anti-smuggling and anti-corruption initiatives.

The Presidential Management Staff (PMS) requires that agency inputs be reported in such a manner that is relatable and meaningful to the general public.

The following reports, (covering July 2016 to present) must be submitted:

- a) Volume and value of consolidated balikbayan boxes from the time the said provision (Section 800, CMTA), citing the volume/value against the immediately preceding year when there was no such provision yet;
- b) Volume of importations under De Minimis, citing comparison against immediately preceding year when the old TCCP provision was still applied;
- c) Number of anti-smuggling operations and corresponding estimated value of seized smuggled goods as compared against 2015;
- d) Revenue gained from auction of goods seized through anti-smuggling operations, with comparison against 2015;
- e) Comparison on the number of cases filed 2015 vs 2016 under RATS/BATAS; and
- f) Apprehensions/seizures from Alert Orders under COMCEN vs 2015 when there was no centralized issuance of Alert Orders.


