CUSTOMS ADMINISTRATIVE ORDER
NO. 10-2006

SUBJECT: REVISED RATES OF OVERTIME PAY IN ALL SEAPORTS AND AIRPORTS OF ENTRY UNDER THE EAST ASIA GROWTH AREAS (EAGA) FOR VESSELS AND AIRCRAFTS INCLUDING CARGOES COMING FROM MEMBER COUNTRIES OF THE "BRUNEI, INDONESIA, MALAYSIA, PHILIPPINES – EAST ASIA GROWTH AREAS" (BIMP-EAGA), AMENDING FOR THAT PURPOSE CUSTOMS ADMINISTRATIVE ORDER NOS. 2-2004 AND 1-2005

By authority of Section 608 and in relation to Sec. 3506 of the Tariff and Customs Code of the Philippines, as amended, the following rates of overtime pay rendered by customs officials and employees payable by shipping companies and other parties served are hereby prescribed, as follows:

- I. **Revised Rates of Overtime Pay**
 - A. **Seaports of Entry**
 1. **On-Board Vessel**
 - a. Boarding Formalities - P 750.00/vessel
 - b. Entrance and Clearance - 362.50/vessel
 - c. Supervision over Loading and Unloading of Cargoes - 1,500.00/day
 - d. Supervision of Vessel for emergency call such as bunkering, discharging patient, sheltering, repair, stress of weather, marine accident, dockyard lay up and others - 750.00/day
 - B. **At the Pier/Ship-side**
 1. **Cargo Control Supervision and Examination rendered by the following customs officers and employees:**
 - a. COO III and COO II - 33.50/hr.
 - b. COO I - 30.00/hr.
 - c. Asst. COO - 26.50/hr.
 - d. Customs Container Control Division/ or equivalent unit - P 1,250.00/day
 - C. **Airports of Entry**
 1. Collector of Customs - P 41.50/hr.
 2. Supervisor/COO V/Boarding Officer - 37.00/hr.
 3. COO III/Inspector/Cashier/Document Processor/Warehouseman/Storekeeper - 35.00/hr.
 4. Clerk/Customs Guard/Gatekeeper - 33.00/hr.

- II. **REPEALING CLAUSE.** – All customs orders and other issuances which are inconsistent with this Order, or any part hereof are hereby repealed or amended accordingly.
- III. **APPLICABILITY.** – This Administrative Order shall only apply to all sea ports and airports of entry under the East Asia Growth Areas (EAGA), for vessels and aircrafts as well as cargoes coming from member countries of "Brunei, Indonesia, Malaysia, Philippines-East Asia Growth Areas (BIMP-EAGA).
- IV. **EFFECTIVITY.** – This Order shall take effect upon approval of the Secretary of Finance.
