## CUSTOMS ADMINISTRATIVE ORDER (CAO) NO. 04 - 20/6

SUBJECT: AMENDMENT OF CUSTOMS ADMINISTRATIVE ORDER (CAO) 10-2007 ON THE RATE OF THE AUCTION BOND

**Section 1.** <u>Objective</u>. Pursuant to Section 1141 of Republic Act No. 10863 or the "Customs Modernization and Tariff Act of 2016" (CMTA), **Section 7.c** of CAO 10-2007 is hereby amended to read as follows:

"SECTION 7. **CONDITIONS FOR REGISTRATION AND PARTICIPATION IN PUBLIC BIDDING. -** The Chief, ACDD shall be responsible to ensure that only those who have complied with the following requirements shall register and participate in the public auction:

c. Posting of a duly receipted bond in cash or manager's check, in accordance with the schedule shown below:

FLOOR PRICE						BOND <sup>1</sup>
Not over				Php	10,000.00	NONE
Over	Php	10,000.00	but not over	Php	1,000,000.00	20%
Over	Php	1,000,000.00	but not over	Php	2,500,000.00	15%
Over	Php	2,500,000.00	but not over	Php	5,000,000.00	10%
Over	Php	5,000,000.00				5%

The bond shall be refunded to the losing bidder after the closing of the auction. The bond shall not, however, be required when the floor price of a sale lot is Php10,000.00 or less."

**Section 2.** <u>Periodic Review</u>. Unless otherwise provided, this CAO shall be reviewed every three (3) years and be amended or revised, if necessary.

**Section 3.** Repealing Clause. This CAO specifically amends or repeals previously issued CAOs and Customs Memorandum Orders (CMO) which are inconsistent with the provisions herein stated.

**Section 4.** <u>Separability Clause</u>. If any part of this CAO is declared unconstitutional or contrary to existing laws, the other parts not so declared shall remain in full force and effect.

**Section 5.** <u>Effectivity</u>. This CAO shall take effect after fifteen (15) days from publication at the Official Gazette or a newspaper of national circulation.
