

## INVITATION TO BID

## Invitation to Bid for Expansion of the Administration Building at Port of Davao

- 1. The Bureau of Customs, through the GAA for CY 2012 intends to apply the sum of twen million pesos (20,000,000.00) being the Approved Budget for the Contract (ABC) payments under the contract for the Expansion of Administration Building at Port Davao. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Bureau of Customs now invites bids for the Expansion of Administration Building at Port of Davao located at Sasa Road, Davao City. Completion of the Works is required for a period not exceeding 150 calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from the General Services Division, Bureau of Customs, Port Area, Manila and Bureau of Customs, Port of Davao located at Sasa Road, Davao City and inspect the Bidding Documents at the address given below during office hours starting September 28 to October 29, 2012.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of four thousand pesos (Php50,000.00).
- 6. The Bureau of Customs, Bids and Awards Committee will hold a Pre-Bid Conference on October 15, 2012 at 10:00 A.M. at the Conference Room in District Collector's Office, Port of Davao located at Sasa Road, Davao City which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before Monday, October 29, 2012 at Conference Room in District Collector's Office, Port of Davao located at Sasa Road, Davao City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The Bureau of Customs reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
