Later that day, unfortunately, we received a letter that container was placed under alert and actual inspection done October 5, 2018 with the ITCSI, District Collector, Representative of the consignee and other witnesses stated on the memorandum given, result turned out to be "Negative" and it is advised that processing to continue.

AFFIDAVIT OF LOSS

I, IMELDA S. BANAL, of legal age, married with office address at 1012 Morong St., Manuguit Subd, Tondo, Manila after having been duly sworn in accordance with law, depose and

That I am the owner of **I.S Banal Customs Brokerage** with office address stated above; That around June 30, 2018, I attended to the processing of the shipment of our client-consignee TRT ENTERPRISE whose shipment consisting of Used Household Goods entered to the Manila International Container Port under B/L No. INC2421832 in Container No. FCIU7220115. The shipment was registered as Import Registry Entry No. C-201780-18 (referred to as subject shipment");

That as part of my completing the documents in our file, I borrowed from the Appraiser-assigned to us the following original document (referred to as the "subject shipping documents") to be photocopied:

- A) The Commercial Invoice;
- B) The Packing List;
- C) Sales Contract;
- D) Bill of Lading; and
- E) Single Administrative Document (SAD-E2M)

That after photocopying these documents on site (as the MICP), I returned these documents to the Appraiser-assigned to our shipment. I attached the photocopied documents to our office file; these photocopies I hereby enclose in this Affidavit as ANNEXES "A", "B", "C", "D:, "E", respectively, for your references.

That unfortunately, our shipment was placed under alert and detained at the Manila International Container Port. It was on October 05, 2018 when the shipment was finally opened by the new appraiser and declared to be **NEGATIVE** of contraband;

In the meantime, it appears that the originals of the subject shipping documents which I borrowed from the former appraiser-assigned could not be found in the files of the Bureau of Customs; that I was the only one who took them out of the premises of the BoC that day of 30^{th} July 2018.

I remember that on that same day, I also have in my possession other shipping documents related to other clients. It is now clear that I mistook these other files I had that time and which I mistakenly turned over to the appraiser IN PLACE of the correct subject shipping documents. These original documents of the subject shipment, in return, I unfortunately, brought back to the office, misfiled or lost, and can no longer be located.

That, I hereby declare under oath, that it was not my intent not to return the originals of the shipping documents of the subject shipment that my failure to return these to the BoC was due only to excusable error caused no doubt by my confusion, inattention and harassed condition as I was distracted by other office matters that day.

That I further state that the photocopies of the documents which I have attached to this affidavit are the faithful reproduction of the originals of the documents which I lost.
