CUSTOMS MEMORANDUM CIRCULAR No. \_\_\_\_ 335 - 2018

To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 15 - 2016, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on November 14, 2018 shall be the applicable Rate of Exchange for the week November 15, 2018 – November 21, 2018 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
