SUBJECT:

Exemption on the Imposition of Special Safeguard (SSG) Duty on Certain Agricultural Products that Carry Valid SPS Import Clearance (SPSIC) that were issued within the Period 16 August – 17 October 2018.

With reference to the request letter dated November 06, 2018 from Secretary Emmanuel F. Piñol, Department of Agriculture, All Concerned are informed that shipments of the below listed agricultural products that carry valid SPS Import Clearance (SPSICs) that were issued within the period 16 August – O17 October 2018 are exempted from the SSG duty, to wit:



This concerns the reinstatement of the price-based special safeguards (SSG) duty on the following imported chicken and chicken products pursuant to Customs Memorandum Circular (CMC) No. 209-2018 dated 17 October 2018:

Recall that the imposition of SSG on these products was temporarily lifted on 16 August 2018 through CMC No. 173-2018 which we requested as part of the measures to address rising prices of food items and mitigate soaring inflation. During the period of this temporary lifting, this Department issued a number of SPS Import Clearances (SPSIC) covering shipments of these products. By the time the imposition of the SSG was reinstated on 17 October 2018, however, some of these shipments have yet to arrive in the Philippines.

In this regard, we would like to request that shipments of these products that carry valid SPSICs that were issued within the period 16 August-17 October 2018 be exempted from the SSG duty. We attach a copy of a valid SPSIC for the Bureau's reference.
