This CMC is issued pursuant to CAO 2-2001 and CMO 15-2002.



AFFIDAVIT OF LOSS

I, REYNALDO A. ABESAMIS, of legal age, with office address (At Robbs BIM, FEMIL depose and state:

- 1. I am the Customs Representative of Licensed Customs Btroker MEL REBECCO MACARAT, Room 314, FEMII Bldg., A. Soriano Ave., Intramuros, Manila, whose client, MBM ENTERPRISES.
- 2. MBM ENTERPRISES filed a request for tentative release of its shipment of 1x20' Container STC: Remote Controlled Tricycles, Scooters, Pedal Cars and Similar Wheeled Toys Dolls Carriages classified under TH 9503.0010 at 0% whose declared value was adjusted based on the Import Assessment Service recommended value from US\$9,525.94 to US\$40,849.86. The adjustment of the value resulted in discrepancy assessment of P193,381.00 which was covered by Cash Bond as evidenced by under BCOR No. 5945074.
- 3. On July 30, 2018, the VCRC issued a disposition form for the subject VCRC Docket No. 0008-17 which accepted the declared value by the importer and for the release of the cash bond issued thereon in the aforesaid amount of P193,381.00 which was approved by the District Collector and Chairman, VCRC
- 4. However, due to the transfer of the said documents from one office to another, the original of the documents pertaining to the said docket number were lost in transit. I have attached herewith the photocopies of the docket thereof, for your guidance.
- 5. I have exerted maximum efforts to locate the said docket containing the original of the pertinent documents, but the same have proved futile. The said document are now deemed list and irretrievable.
- 6. In this connection, and pursuant to Customs Memorandum Order (CMO) No. 15-2002, we would like to request for the reconstruction of the lost original documents pertaining to the subject VCRC Docket in order that we may be able to release the cash bond that was posted for the tentative release of the subject shipment.
- 8. I am executing this Affidavit in order to attest to the truth of all the foregoing and for whatever legal and useful purpose it may serve.
