DESCRIPTIVE REPORT WEEKLY REPORT for June 25-29, 2018

Port of Clark has recorded 29 formal entries, 1,311 transshipment entries, 18 warehousing entries, 90 informal entries and 1,014 export entries which were filed and completed this week, gathering a total of 2,462 entries.

There are no reports on auction and apprehensions. However, an Alert Order was issued against a shipment with consignee Mark C. Ortaleza. Furthermore, a Warrant of Seizure and Detention was issued against 50 units of mobiles phones found inside a luggage carried by a Chinese passenger Wei Rongjin at the Clark International Airport for lack of import permit.
