July 27- August 02, 2018

Dr. Wivina B. Pumatong, CESE received a Certificate of Commendation for the successful collection of lawful duties and taxes surpassing the monthly target for July 2018 with 18.83%. Below is the summary of data:

On the same day, Dr. Pumatong attended the BOC Command Conference together with Commissioner Isidro S. Lapeña and all Deputy Commissioners, District Collectors, Service Directors and Division Chiefs at Port of Manila.

On August 08, 2018, Dr. Wivina B. Pumatong, CESE, Acting District Collector of this Port attended a meeting together with Philippine Ports Authority and Visvets Port Services Inc. regarding the proposed establishment of Iloilo International Container Port.

For this week, the entire district has a total of 11 entries filed; export and formal entries.

At the main office, six (6) formal entries were filed; two (2) were completed and four (4) are still in progress. One (1) export was filed and completed.

For the Subport of Pulupandan, four (4) formal entries were filed and completed; two (2) were completed and two (2) are still in progress.

There are no reports for balikbayan boxes, auctions, alert orders and apprehensions. Newly promoted employees of the Collection District will have a refresher course seminar on August 14-17 and August 28-31, 2018. Different personnel from this port will be sent to scheduled trainings and seminars for the month of August which will be conducted by Civil Service Commission, Regional Office VI. #
