

## **NARRATIVE REPORT**

*July 13-23, 2018*

The Bureau of Customs Port of Iloilo recognized the faithful and lawful payment of duties and taxes of the TOP IMPORTERS for the First Semester of 2018 on Monday, July 23, the first time award ceremony has been held at the Rigor Hall, Iloilo Customhouse Building. Dr. Wivina B. Pumatong, CESE, Coll. Renevic A. Soliman and Atty. Ramon Rory A. Antiojo handed out the Plaque of Recognition to the 10 importers from across Collection District VI, which are the following: 1) Seaoil Philippines Inc., 2) Panay Energy Dev't Corp., 3) Palm Concepcion Power Corp., 4) Isla Petro and Gas Corp., 5) Fortem cement Corp., 6) Marlusa Construction Supply., 7) SCG Marketing Phil. Inc. 8) R. Queens Int'l Trading Corp., 9) Petronas Energy Phils. Inc., 10) La Filipina Uygongco Corp.

An Audio-Visual Presentation highlighting the Five Point Agenda and Priority Program of Commissioner Isidro S. Lapena was shown on the said event.

A refresher course discussion for CMO 16-2010 "Rules and regulations to implement CAO No. 4-2004, more particularly on dutiable value" was conferred by Dr. Wivina B. Pumatong, CESE, Acting District Collector to the employees of Collection District VI.
