Weekly Report to PIAD

Brief Narrative *(April 1-5, 2019)*

For the period *April 1-5, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: one (1) in-progress and four (4) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php13,206,035.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
