Filing/submission of all participants (whether natural or juridical) accomplished and duly notarized Bidder's Information Form, certified true copy of the latest Income and Business Tax Returns duly stamped "RECEIVED" by the Bureau of Internal Revenue with the validated tax payment made thereon and documentary stamp and other documents such as ID, Community Tax Certificate, Business Permits, Certificate of Registration of Business Name issued by the Department of Trade and Industry or Securities and Exchange Commission, Special Power of Attorney/Board Resolution for the specific auction sale and other pertinent documents must be submitted on or before May 29, 2018 at $5: 00 \mathrm{pm}$. Any new, additional, supplemental or remedial paper/document shall no longer be accepted after the said deadline.
2. Payment of PhP 2,020.00 Registration Fee (non-refundabie).
3. For Sale Lot Nos. 4-2018 and 9-2018, Interested bidders must be member of Philippine Wood Producer Association (PWPA);

For Sale Lot No. 12-2018, Interested bidders must be a DTI and LTO Accredited Truck/Bus/Rebuilders.

The Bond shall be refunded to the losing bidder after the closing of the auction.
5. At the end of the bidding, the highest bidder shall be required to pay in cash/manager's check equivalent to fifty percent ( $50 \%$ ) of the bid price "ON THE SPOT" upon announcement of the winning bid on top of the bond in cash or manager's check as required in No. 4 hereof. The remaining balance shall be paid on the succeeding business day. Failure to make any of the payments as required shall disqualify the bidder from participating further in the auction sale and the negotiated sale thereof, if applicable. This is without prejudice to the forfeiture of the cash bond and other payments made and the imposition of other sanctions as may be warranted.
6. The auction shall be conducted through sealed bids, which shall be submitted and opened in public by Auction Committee at a time, date and place specified in the notice of Auction Sale.
7. The highest bid shall be declared as the winner except when clustering occurs. Clustering occurs when the difference between the highest and second highest bid is within the ten percent ( $10 \%$ ) of the highest bid. In such case, an open bidding shall be conducted among the bidders of the particular sale lot who are present with the highest bid serving as the new floor price. Only bids raised by three percent ( $3 \%$ ), more than the new floor price shall be considered and the highest bid in the open bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared as the winner.
8. A failed bidding shall be declared by the Auction Committee when any of the following circumstances occurs;
a. When there is only one sealed bid, the same shall not be opened;
b. When there are two sealed bids but there is only one bid higher than the floor price.
9. Non-Compliance with any of the terms and conditions of the Notice of Public Auction shall result in the forfeiture of any payments made by the winning bidder without prejudice to the forfeiture of the subject shipments in favor of the government.
10. The winning bidder shall withdraw in full the total quantity of the shipment as indicated in the Notice of Award in Five (5) working days. Otherwise, a storage fee based on existing rates shall be imposed/charged according to CMO 59-90.
11. Payment with Manager's Check to the Bureau of Customs, District Port of Cebu (BOC, POC) shall bear:

12. The Bureau of Customs, District Port of Cebu, reserves the right to ensure that only those who have complied with the herein enumerated requirements shall register and participate in the public auction.
