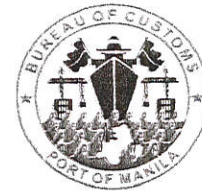




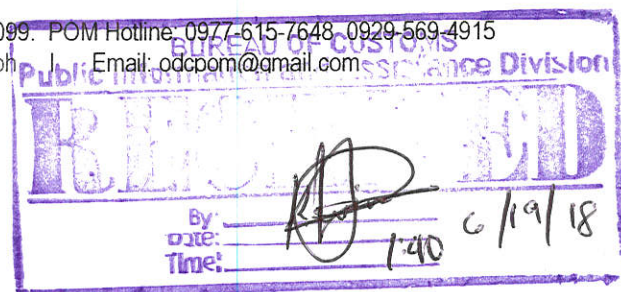
DISCUSSION:
