LEASE OF K9 NARCOTICS TRAINED DETECTION DOG

This Addendum No. 1 dated March 2, 2017 is issued to clarify, modify or amend items in the Bid Documents. This shall form an integral part of the Bid Documents.

The bidder must have completed, five (5) years prior to March 9, 2017, a single contract of narcotic detection dogs, rental or sale, and if the single contract whether sale or rental includes explosive detection dogs or rental of teams, the narcotic detection sale or rental portion must have a value of at least fifty percent (50%) of the ABC to be bid. Such contract must be part of, or included in, the Statement under Item 12.1 (a) (ii) hereof. This is to avoid undermining the very purpose of the Narcotic Detection exclusivity of the project.</p> <p>For this purpose, similar contract shall exclusively refer to completed Lease or Sale of Narcotic Detection Dogs. Explosive Detection contract of lease or sale shall not be considered acceptable as it is a different K9 requirement.</p>	<p><i>Section III. Bid Data Sheet</i></p> <p>5.4. Special Conditions of Contract</i></p> <p>17.3 Supplier warrants that the Narcotic Detection Dogs are suitable for purpose for which they shall be employed, conform to the BOC approved technical specifications, free from congenital defects of whatever nature and, in case anyone of them shall die or be incapable to perform any of the purposes for which they were procured immediately from receipt of notice.</p>
