CUSTOMS MEMORANDUM CIRCULAR No. 149 - 2015

To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 14 - 2002, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on 23 October, 2015 shall be the applicable Rate of Exchange for the week October 24, 2015 – October 30, 2015 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
