NFA informs that the **PITC** did not apply for an import allocation under the 2017 Minimum Access Volume (MAV) Rice Import Program. Thus, they did not issue any of the above mentioned Import Permits. Further, the arrivals of 2017 MAV shipments commenced only last December 20, 2017 up to February 28, 2018 for the Phase 1 arrival schedule, and June 1, 2018-August 31, 2018 for the Phase 2 arrival schedule.

Also, NFA informs that as per NFA Council-approved Guidelines, the Import Permits under the 2017 MAV Rice Importation Program has a validity of only fifteen (15) calendar days from the date of issuance and not one (1) year as specified in these spurious Import Permits.


