All must be properly signed and sealed. Must be submitted in hard copy.

Submission of quotation and eligibility documents is on or before **November 27**, **2023**, **10:00** a.m., at **General Services Division (GSD)**, **Ground Floor**, **OCOM Building**, **Port Area**, **Manila**.

Award of contract shall be made to the lowest quotation, which complies with the minimum description as stated above and other terms and conditions stated in the price quotation form.
