CUSTOMS MEMORANDUM ORDER

Subject: Delegation of Signing/Approving Authority

I. COVERAGE

To expedite action on customs matters requiring final action/clearance from this Office, the authority to act on such matters is hereby delegated to Customs officials as hereinbelow indicated:

A. Deputy Commissioner Titus B. Villanueva

1. Clearance under the following CMO's/Memorandum

- 1.1 CMO 54-89, CMO 79-90 (Consolidated shipment)
- 1.2 CMO 71-90 (Lack of BIS Authority & SGS-CRF requirement)
- 1.3 Memorandum of January 9, 1991 as amended, on importation of steel
- 1.4 CMO 21-88 (Importation of Motor Vehicles)
- 1.5 CMO 100-89, CMO 18-90 (Importation of Motor Vehicles under RP-US Military)
- 1.6 CMO 1-91 (Shipments declared as coming from Pakistan, India and Sri-Lanka)

2. Request for Value information pursuant to CMO 33-91.
3. Application for authority to operate Customs Bonded Warehouse/  
Subcontracting/extension of Warehousing Storage Period.

B. Deputy Commissioner Licerio C. Evangelista

1. Claims for Tax Credit Certificates EXCEPT those covering Duty-Drawback, BOI - granted tax refund, request for transfer of tax credits, and those in connection with abatement of duties.
2. Accreditation of Insurance Companies.
3. Claim for rewards

II GENERAL PROVISION

1. All papers/documents executed in accordance herewith shall be so signed in behalf of the Commissioner. Hence the signature shall follow the phrase "APPROVED FOR THE COMMISSIONER"
2. All Disposition Forms and supporting documents pertaining to the said customs matters shall no longer pass the Office of the Commissioner but shall be forwarded directly to the respective offices of Deputy Commissioner Villanueva and Deputy Commissioner Evangelista, for final action in accordance with this Order, existing laws, rules, regulations and policies applicable in the premises.
3. Deputy Commissioner Villanueva and Deputy Commissioner Evangelista shall submit a weekly report to the Commissioner of Customs on all matters acted upon by virtue of this delegated authority. The report shall include a clean copy of the accomplished Disposition Forms and implementing indorsement, memorandum, circular, or letter as the case may be.
