ALL COLLECTORS OF CUSTOMS ALL SERVICE/DIVISION CHIEFS AND ALL OTHERS CONCERNED

SUBJECT:

AMENDMENT TO CMO 23-92

IMPLEMENTING JOINT CIRCULAR NO. 2-91

To facilitate the collection of customs duties and taxes from importing government entities on their importations released from customs custody without the required pre-payment of customs duties and taxes, the hereunder amendment is hereby promulgated:

Paragraph II (1), CMO 23-92 which originally reads:

"The Collection Service shall only be able to transmit officially the Notice to Release without Prepayment of Duties and Taxes to the proper port of entry upon receipt of the original copy of the Bill of Lading or Airway Bill from the importing agency."

shall be AMENDED TO READ:

The Collection Service shall only be able to transmit officially the Notice to Release without Prepayment of Duties and Taxes to the proper port of entry upon receipt from the importing agency of the following documents:

1) Shipping documents

Original copy of the Bill of Lading or Airway Bill; and

CMB-113-92

2) Certificate of Undertaking

The Certificate of Undertaking (see attached sample form) shall be duly signed by the head of the importing government entity and/or the Director of the Financial and Management Service or the equivalent officials in local government, government hospitals, educational and other institutions covered by JC 2-91.

The Undertaking shall contain, among other things:

- 2.1 The particulars of the shipment;
- 2.2 The declared duties and taxes on the shipment; and
- 2.3 The commitment to settle the duties and taxes within the next succeeding quarter.

This order shall be effective 02 November 1992.

All concerned shall be informed accordingly.
