CUSTOMS MEMORANDUM ORDER NO. 0 - 2017

SUBJECT: AMENDMENT TO CMO 15-2015 DATED 5 JUNE 2015 ENTITLED "OPERATION AND SUSTAINMENT OF PROGRAM-PROVIDED EQUIPMENT (PPE) FOR DETECTION OF WEAPONS OF MASS DESTRUCTION (WMD) UNDER THE NATIONAL COAST WATCH SYSTEM

(NCWS) PROJECT, PURSUANT TO EXECUTIVE ORDER (EO) NO. 57, SERIES OF 2011"

Executive Order (EO) No. 57 (s. 2011), establishing the National Coast Watch System (NCWS), identifies the Bureau of Customs (BOC) as one of the support agencies tasked to provide manpower, equipment, and material support to the NCWS and its operations.

As part of its commitment to support the NCWS, the BOC, through Customs Memorandum Order (CMO) No. 15-2015, constituted the BOC NCWC Task Group. The Task Group is tasked to oversee BOC activities implemented by the National Coast Watch Council (NCWC), as well as recommend and draft rules and regulations, and operating procedures necessary for the effective implementation of the NCWS, among others.

In line with the objectives of EO 57 (s. 2011) and the commitment of the Bureau to the NCWS, the BOC NCWC Task Group constituted under CMO No. 15-2015 is hereby reconstituted as follows:
