
GREETINGS:

WHEREAS, this Court in its order dated, December 20, 2013,
granted the Application for a Writ of Injunction upon posting by plaintiff
of an injunction bond in the amount of TEN MILLION PESOS
(P10,000,000.00) in favor of the defendants to answer for any and all
damages that the latter may suffer because of injunction;

WHEREAS, the petitioner posted a cash bond in the amount of TEN
MILLION PESOS (P 10,000,000.00) for preliminary injunction;

NOW THEREFORE, respondents BUREAU OF CUSTOMS, DISTRICT COLLECTOR in his capacity as the District Collector for the Port of Manila, South Harbor, NATIONAL FOOD AUTHORITY, HON. ORLAN A. CALAYAG, in his capacity as the Administrator of the National Food Authority, NFA COUNCIL, HON. PROCESO J. ALCALA, in his capacity as Chairman of the NFA Council, OFFICE OF THE SOLICITOR GENERAL and all persons acting on their behalf and/or under their direction and control are enjoined from implementing NFA Memorandum Circular No. AO-2K13-03-003; requiring the procurement of an important permit for all rice importation to the Philippines by the petitioner in the Port of Manila; seizing, alerting and/or holding petitioner's rice shipments, including but not limited to those covered by the Bills of Lading mentioned in the subject petitions, and those shipments which may have previously arrived in the Philippines, those which are expected to arrive or will arrive after the filing of the instant petition or during its pendency in any port in within the territorial jurisdiction of this Court; and implementing any alert and/or hold order, and consequently lifting any alert and hold order, relative to petitioner's rice shipments including but not limited to those covered by the Bills of Lading mentioned in the instant petition or during its pendency in the Port of Manila that is within the jurisdiction of this Court.


ORDER
