The Government Service Insurance System (GSIS) will accept applications to the GSIS Scholarship Program (GSP) for Academic Year 2019-2020 until 24 June 2019.

The GSP is open to qualified members and Permanent Total Disability (PTD) pensioners below 60 years old who have incoming college children/dependents accepted or enrolled in any four- or five-year college course or priority course (Annex A) identified by the Commission on Higher Education (CHED) in a higher education institution that has its own charter or a school qualified by the CHED as Levels IV and III, autonomous, or with a deregulated status (Annex B).

Qualified members who may apply include active and regular GSIS members who have salary grades of 24 and below, or its equivalent job level. In addition, childless married members and single members are also eligible. For PTD pensioners, their last compensation shall serve as basis in the selection process.

The program is also offered to persons with disabilities, indigenous peoples and solo parents (as defined under the Solo Parent's Welfare Act of 2000) who are GSIS members.

Chosen scholars will enjoy the following benefits:

- Actual cost of tuition and miscellaneous fees not exceeding Php40,000 per academic year; and
- Monthly stipend of Php3,000 for the duration of the course.

We would appreciate your continued support and cooperation, specifically in informing and disseminating the program to your employees.

Details of the program are contained in the attached factsheet. Application forms may also be downloaded from the GSIS website, www.gsis.gov.ph.
