SUBJECT: AMENDMENT OF THE LIST OF STRATEGIC GOODS TO BE

EXPORTED BY TOYO INK COMPOUNDS CORPORATION (TICC)

Attached herewith is the letter dated October 12, 2021 from Atty. Luis M. Catibayan, Director, Strategic Trade Management Office, Department of Trade and Industry (STMO-DTI) referring to this Bureau the DTI-STMO's grant letter with reference STRAD-LR158/18 dated August 6, 2021 previously issued to TICC. DTI-STMO informs of the amendment of the list of strategic goods to be exported (as attached) by TICC.

Relationship with Exporter: Toyo Ink Mexico is a subsidiary company of Toyo Ink Compounds Corporation whose parent company is Toyo Ink SC Holdings

The approval, however, is subject to the following conditions, that:

- a. the grant letter is valid only from November 15-December 15, 2021. Any export of the strategic item/s stated in the grant letter, earlier or beyond the validity date will require Authorization from the STMO-DTI;
- b. the items listed in the letter shall be shipped only and directly to the stated end-user;
- c. no re-export/ re-transfer shall be conducted without prior written authorization from Mexico;
- d. once the item is shipped, the documents (including photos) certifying the export id goods to the end-user must be submitted to the STMO within fifteen (15) calendar days; and
- e. TICC is subject to the STMO compliance visit and will provide a report regarding usage of the grant letter, as needed by the STMO.
