SUBJECT: Korea's Change in Certificate of Origin (CO) Numbering System

Under the ASEAN-Korea Free Trade Agreement (AKFTA)

Attached hereto is the letter dated 21 November 2019 of Atty. Allan B. Gepty, Assistant Secretary, Bureau of International Trade Relations, regarding the change in the numbering system for the issuance of ASEAN-Korea Free Trade Agreement (AKFTA) Certificate of Origin (CO Form AK) starting November 9, 2019.

Previously, replacement CO Forms were issued the same number as the original CO Form. Under the new scheme of Korea, replacement CO Forms will be issued its own reference number. This is in line with the AKFTA Operational Certification Procedures Rule 5 which states that Certificates of Origin shall bear a reference number separately given by the issuing authority.

First of all, I'd like to appreciate your effort to implement Korea-ASEAN FTA.

Up until now, issuing authorities of Korea (Korea Customs Service & Korea Chamber of Commerce & Industry) have been using the same reference number even in the newly issued CO after correcting the initially issued one.

However, we inform you that starting from November 19th 2019 the newly issued CO will be offered with the new reference number after correction, in recognition that the corrected CO is actually a new CO.

We anticipate this change will largely contribute to the trade between the two parties as well as the implementation of Korea-ASEAN FTA.
